MEMBERSHIP

Article III. Membership

Section 1. Eligibility for membership shall be open to members of the New York Correction Department who are of Irish lineage or Irish Spirit. There shall be three classes of membership:

Section 2. Membership in the Emerald Society is divided into three classes: **Regular membership**, **Associate membership** and **Honorary membership**.

A) Regular membership – Any active or Retired Member of Service (retired or resigned after honorable and faithful service) of the Department with Irish lineage. Any Civilian employee Active or Retired (retired or resigned after honorable and faithful service) of the Department with Irish lineage.

B) Associate Membership – Any Active or Retired MOS/Civilian Employee (retired or resigned after honorable and faithful service) of the Department with “Irish Spirit”. Associate members have no voting rights and cannot be nominated or elected to any office.

C) Honorary Membership- shall consist of such Individuals as shall be recommended to be approved by the Membership. Honorary Members shall have no vote and no voice in the affairs of the Society. Honorary Members are entitled to participate in meetings and social activities of the Society.
